On the Automorphisms of a Rank One Deligne–Hitchin Moduli Space

Abstract. Let X be a compact connected Riemann surface of genus $g \ge 2$, and let \mathcal{M}_{DH} be the rank one Deligne–Hitchin moduli space associated to X. It is known that \mathcal{M}_{DH} is the twistor space for the hyper-Kähler structure on the moduli space of rank one holomorphic connections on X. We investigate the group Aut(\mathcal{M}_{DH}) of all holomorphic automorphisms of \mathcal{M}_{DH} . The connected component of Aut(\mathcal{M}_{DH}) containing the identity automorphism is computed. There is a natural element of $H^2(\mathcal{M}_{DH},\mathbb{Z})$. We also compute the subgroup of Aut(\mathcal{M}_{DH}) that fixes this second cohomology class. Since \mathcal{M}_{DH} admits an ample rational curve, the notion of algebraic dimension extends to it by a theorem of Verbitsky. We prove that \mathcal{M}_{DH} is Moishezon.

1 Introduction

The moduli spaces of Higgs bundles on a compact Riemann surface arise in various contexts and are extensively studied. One of the reasons for their usefulness is the nonabelian Hodge correspondence which identifies the moduli space of semi-stable Higgs bundles of rank r and degree zero on a compact Riemann surface X with the character variety

 $\operatorname{Hom}(\pi_1(X), \operatorname{GL}(r, \mathbb{C}))//\operatorname{PGL}(r, \mathbb{C})$

(see [4, 5, 8, 10]). This identification is a C^{∞} diffeomorphism between the open dense subset consisting of stable Higgs bundles and the open dense subset consisting of irreducible representations. However, this diffeomorphism is not holomorphic. In other words, there are two different complex structures on a moduli space of Higgs bundles, one from being the moduli space of Higgs bundles and the other given by the complex structure of the character variety via the above mentioned identification. In fact, these two complex structures are a part of a natural hyper-Kähler structure on a moduli space of Higgs bundles over X [8]. It was noticed by Deligne and Hitchin that the twistor space associated to this hyper-Kähler manifold also has an interpretation as a moduli space; see [11, 12] for many properties of these spaces.

In a recent interesting paper [2], Baraglia computed the various automorphism groups associated to a moduli space of Higgs bundles on X (like holomorphic automorphisms preserving the holomorphic structure, holomorphic isometries, hypercomplex automorphisms, hyper-Kähler automorphisms et cetera). In [2], the structure group is $SL(r, \mathbb{C})$, hence the moduli space parametrizes Higgs bundles of fixed determinant with the trace of the Higgs field being zero. Inspired by [2], in [3] the case of \mathbb{C}^* -bundles was investigated, where \mathbb{C}^* is the multiplicative group of nonzero complex numbers. More precisely, the automorphism groups of the moduli spaces of rank one Higgs bundles, rank one holomorphic connections and \mathbb{C}^* -character varieties were studied.

Our main aim here is to investigate the automorphisms of the rank one Deligne–Hitchin moduli space. The Deligne–Hitchin moduli spaces are not algebraic varieties; they are complex manifolds. However, they are built out of Hodge moduli spaces which are complex quasiprojective varieties. The rank one Hodge moduli space $\mathcal{M}_{Hod} = \mathcal{M}_{Hod}^X(1)$ parametrizes all rank one λ -connections on a compact Riemann surface X with λ running over \mathbb{C} . The rank one Deligne–Hitchin moduli space $\mathcal{M}_{DH} = \mathcal{M}_{DH}(X)$ is constructed by gluing $\mathcal{M}_{Hod}^X(1)$ and $\mathcal{M}_{Hod}^{\overline{X}}(1)$ over the inverse image of $\mathbb{C}^* \subset \mathbb{C}$, where \overline{X} is the Riemann surface conjugate to X.

It is natural to ask for the automorphism group of the rank one Deligne–Hitchin moduli space as it is the only case missing for rank one, see [3]. In general, automorphisms of moduli spaces associated to a Riemann surface play an important role in mirror symmetry and help to improve our understanding of these objects. The rank one case serves as a motivating and more simple example, where we can gain intuition for what should be expected in general. On the other hand, this task is also interesting for itself as we cannot use an algebraic structure of the moduli space, and algebraicity was at the heart of the proofs in [3]. As a nice additional observation we would like to mention that the automorphisms of the Deligne–Hitchin moduli space are algebraic when restricted to some of its subspaces, i.e., to the Dolbeault, the de Rham and the Hodge moduli space. Finally, and most importantly, we hope that our techniques can be generalized to study automorphism groups of the Deligne–Hitchin moduli space for higher rank. This is of particular interest as certain sections thereof correspond to solutions to important geometric PDE's such as harmonic maps including Hitchin's self-duality equations, and certain automorphisms might give rise to transformations between some classes of PDE's.

We now describe the results proved here. Let $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})$ be the group of all algebraic automorphisms of $\mathcal{M}_{\operatorname{Hod}}$, and let $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$ be the connected component of it containing the identity automorphism. The holomorphic cotangent bundle of X will be denoted by K_X .

Theorem 1.1. The group $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$ fits in a short exact sequence of groups

$$0 \longrightarrow \mathbb{V} \stackrel{\iota}{\longrightarrow} \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0 \stackrel{h}{\longrightarrow} \operatorname{Pic}^0(X) \times \mathbb{C}^* \longrightarrow 0,$$

where \mathbb{V} is the space of all algebraic maps from \mathbb{C} to the affine space $H^0(X, K_X)$.

Define $\Gamma_X := \operatorname{Aut}(X)$ if X is hyperelliptic, and $\Gamma_X = \operatorname{Aut}(X) \oplus (\mathbb{Z}/2\mathbb{Z})$ if X is nonhyperelliptic. This group Γ_X has a natural action on $\mathcal{M}_{\operatorname{Hod}}$ via holomorphic automorphisms; see Section 2.2. Let

$$\Gamma_X := \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0 \rtimes \Gamma_X$$

be the corresponding semi-direct product (see (2.13)). There is a natural cohomology class

$$\theta \in H^2(\mathcal{M}_{\mathrm{Hod}},\mathbb{Z}),$$

and the action of $\widetilde{\Gamma}_X$ on \mathcal{M}_{Hod} fixes θ .

Proposition 1.2. Assume that genus(X) > 1. The group $\widetilde{\Gamma}_X$ coincides with the subgroup of Aut(\mathcal{M}_{Hod}) that fixes θ .

Let $\mathcal{M}_{DH} = \mathcal{M}_{DH}(X)$ be the rank one Deligne–Hitchin moduli space for a compact Riemann surface X. Let $\operatorname{Aut}(\mathcal{M}_{DH})$ be the group of all holomorphic automorphisms of \mathcal{M}_{DH} , and let $\operatorname{Aut}(\mathcal{M}_{DH})_0 \subset \operatorname{Aut}(\mathcal{M}_{DH})$ be the connected component of it containing the identity map. The moduli space of rank one connections on X will be denoted by $\mathcal{M}_{dR}(X)$; it is an algebraic group.

Theorem 1.3. There is an isomorphism

$$\operatorname{Aut}(\mathcal{M}_{\mathrm{DH}})_0 = \mathcal{M}_{dR}(X) \times \left(\left(H^0(X, K_X) \times \overline{H^0(X, K_X)} \right) \rtimes \mathbb{C}^* \right).$$

The group structure of $\mathcal{M}_{dR}(X) \times \left(\left(H^0(X, K_X) \times \overline{H^0(X, K_X)} \right) \rtimes \mathbb{C}^* \right)$ in Theorem 1.3 is described in Theorem 3.7.

The above group Γ_X acts on \mathcal{M}_{DH} . Let

 $\widetilde{\Gamma}_{\mathrm{DH},X} := \mathrm{Aut}(\mathcal{M}_{\mathrm{DH}})_0 \rtimes \Gamma_X$

be the corresponding semi-direct product. There is a natural cohomology class

 $\theta_X \in H^2(\mathcal{M}_{\mathrm{DH}}, \mathbb{Z}),$

and the action of $\widetilde{\Gamma}_{DH,X}$ on \mathcal{M}_{DH} fixes θ_X .

Theorem 1.4. Assume that genus(X) > 1. The group $\widetilde{\Gamma}_{DH,X}$ coincides with the subgroup of Aut(\mathcal{M}_{DH}) that fixes θ_X .

Although \mathcal{M}_{DH} is noncompact, being a twistor space it contains ample rational curves. Verbitsky has shown that in such a context the notion of algebraic dimension continues to hold [13].

We prove the following:

Proposition 1.5. The algebraic dimension of $\mathcal{M}_{DH}(X)$ coincides with dim $\mathcal{M}_{DH}(X) = 1 + 2 \cdot \text{genus}(X)$, or in other words, $\mathcal{M}_{DH}(X)$ is Moishezon¹.

2 Automorphisms of the rank one Hodge moduli space

2.1 Connected component of the automorphism group

Let X be an irreducible smooth complex projective curve of genus g, with $g \ge 1$. The holomorphic cotangent bundle of X will be denoted by K_X .

Definition 2.1. For any $\lambda \in \mathbb{C}$, a rank one λ -connection on X is a pair of the form (L, D), where L is a holomorphic line bundle on X and

 $D: L \longrightarrow L \otimes K_X$

is a holomorphic differential operator of order no more than one such that

$$D(f_0 s) = f_0 D(s) + \lambda \cdot s \otimes (df_0)$$

for every locally defined holomorphic section s of L and every locally defined holomorphic function f_0 on X.

So, if (L, D) is a λ -connection with $\lambda \neq 0$, then D/λ is a holomorphic connection on L; a 0-connection D on L is an element of $H^0(X, K_X)$ because such a D is \mathcal{O}_X -linear. Note that for a λ -connection (L, D), with $\lambda \neq 0$ we have degree(L) = 0 because L admits a holomorphic connection. Also, note that any holomorphic connection on a Riemann surface is automatically flat.

If (L, D) is a 0-connection we will always impose the condition that degree(L) = 0. Let

$$\mathcal{M}_{\mathrm{Hod}} = \mathcal{M}_{\mathrm{Hod}}^X(1)$$

be the Hodge moduli space of rank one λ -connections. So, the points of \mathcal{M}_{Hod} parametrize triples of the form (λ, L, D) , where $\lambda \in \mathbb{C}$, L is a holomorphic line bundle on X of degree zero and D is a λ -connection on L.

Define an algebraic morphism

$$f: \mathcal{M}_{\mathrm{Hod}} \longrightarrow \mathbb{C}, \qquad (\lambda, L, D) \longmapsto \lambda.$$
 (2.1)

For any $\lambda \in \mathbb{C}$, let

$$f^{\lambda} := f^{-1}(\lambda) \subset \mathcal{M}_{\mathrm{Hod}}$$

be the fiber over λ . By definition, the fiber f^0 is the moduli space of Higgs line bundles of degree zero $\operatorname{Pic}^0(X) \times H^0(X, K_X)$ on X, and the fiber f^1 is the moduli space of rank one holomorphic connections on X. The latter space is also called the de Rham moduli space. For $\lambda \neq 0$, the fiber f^{λ} is canonically identified with f^1 by the map $(L, D) \longmapsto (L, D/\lambda)$. We note that f^1 is biholomorphic to the Betti moduli space $\operatorname{Hom}(\pi_1(X), \mathbb{C}^*) = (\mathbb{C}^*)^{2g}$ by sending a holomorphic connection to its monodromy representation, and hence f^1 does not admit a compact submanifold of positive dimension. Since $\operatorname{Pic}^0(X) \times H^0(X, K_X)$ has the projective variety $\operatorname{Pic}^0(X)$ of positive dimension as a subvariety, it follows that f^0 is not biholomorphic to f^1 .

The group of all algebraic automorphisms of the quasiprojective variety \mathcal{M}_{Hod} will be denoted by Aut(\mathcal{M}_{Hod}). Let

$$\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0 \subset \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})$$

be the connected component containing the identity automorphism and let

 $\mathbb{V} :=$ Morphisms $(\mathbb{C}, H^0(X, K_X))$

be the infinite dimensional complex vector space parametrizing all algebraic maps from \mathbb{C} to the affine space $H^0(X, K_X)$. Then we have the following theorem.

Theorem 2.2. The group $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$ fits in a short exact sequence of groups

$$0 \longrightarrow \mathbb{V} \stackrel{\iota}{\longrightarrow} \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0 \stackrel{h}{\longrightarrow} \operatorname{Pic}^0(X) \times \mathbb{C}^* \longrightarrow 0.$$

Proof. Let

 $T: \mathcal{M}_{\mathrm{Hod}} \longrightarrow \mathcal{M}_{\mathrm{Hod}}$

be any algebraic automorphism that lies in $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$. It is known that the fiber f^1 does not admit any nonconstant algebraic function [3, Proposition 2.2]. Since f^{λ} is isomorphic to f^1 for

every $\lambda \in \mathbb{C}^*$, it follows that f^{λ} does not admit any nonconstant algebraic function if $\lambda \in \mathbb{C}^*$. Hence the composition

$$f^{\lambda} \xrightarrow{T|_{f^{\lambda}}} \mathcal{M}_{\mathrm{Hod}} \xrightarrow{f} \mathbb{C}$$

$$(2.2)$$

is a constant function for all $\lambda \in \mathbb{C}^*$. Note that the point $f \circ T(f^{\lambda})$ lies in \mathbb{C}^* because f^0 is not isomorphic to f^{λ} . Since this also holds for T^{-1} , it follows that the composition in (2.2) is a constant function for each $\lambda \in \mathbb{C}$. This implies that there is an algebraic automorphism

$$\tau_0: \mathbb{C} \longrightarrow \mathbb{C}$$

such that

$$f \circ T = \tau_0 \circ f.$$

Since f^0 is not isomorphic to any f^{λ} , $\lambda \in \mathbb{C}^*$, it follows that $\tau_0(0) = 0$. Therefore, τ_0 coincides with the multiplication of \mathbb{C} by a fixed nonzero number; let

$$\tau \in \mathbb{C}^* \tag{2.3}$$

be such that $\tau_0(z) = \tau \cdot z$ for all $z \in \mathbb{C}$.

The group of all automorphisms of the variety $\operatorname{Pic}^{0}(X)$ will be denoted by $\operatorname{Aut}(\operatorname{Pic}^{0}(X))$ (since the variety $\operatorname{Pic}^{0}(X)$ is projective, any holomorphic automorphism of it is algebraic). The connected component of $\operatorname{Aut}(\operatorname{Pic}^{0}(X))$ containing the identity automorphism will be denoted by $\operatorname{Aut}(\operatorname{Pic}^{0}(X))_{0}$. The automorphisms of $\operatorname{Pic}^{0}(X)$ given by translations of the group $\operatorname{Pic}^{0}(X)$ lie in $\operatorname{Aut}(\operatorname{Pic}^{0}(X))_{0}$. In fact, this way $\operatorname{Pic}^{0}(X)$ gets identified with $\operatorname{Aut}(\operatorname{Pic}^{0}(X))_{0}$; note that the Lie algebra $H^{0}(\operatorname{Pic}^{0}(X), T\operatorname{Pic}^{0}(X))$ of $\operatorname{Aut}(\operatorname{Pic}^{0}(X))_{0}$ coincides with the Lie algebra of $\operatorname{Pic}^{0}(X)$ by evaluating sections of $T\operatorname{Pic}^{0}(X)$ at the identity element.

For any $\lambda \in \mathbb{C}$, let ϕ^{λ} be the morphism defined by

$$\phi^{\lambda} \colon f^{\lambda} \longrightarrow \operatorname{Pic}^{0}(X), \qquad (L, D) \longmapsto L.$$
 (2.4)

The fibers of ϕ^{λ} are isomorphic to $H^0(X, K_X)$, because the space of all holomorphic connections on a line bundle $L \in \operatorname{Pic}^0(X)$ is an affine space for the vector space $H^0(X, K_X)$, and $H^0(X, K_X)$ is the space of all Higgs fields on any line bundle. There is no nonconstant algebraic map from an affine space to an abelian variety. Hence, there is no nonconstant algebraic map from a fiber of ϕ^{λ} to $\operatorname{Pic}^0(X)$. Consequently, we get a map

$$\Phi \colon \mathbb{C} \longrightarrow \operatorname{Aut} \left(\operatorname{Pic}^0(X) \right),$$

which is uniquely determined by the condition that the following diagram is commutative

$$\begin{array}{ccccccc}
f^{\lambda} & \xrightarrow{T|_{f^{\lambda}}} & f^{\tau\lambda} \\
\downarrow \phi^{\lambda} & & \downarrow \phi^{\tau\lambda} \\
\operatorname{Pic}^{0}(X) & \xrightarrow{\Phi(\lambda)} & \operatorname{Pic}^{0}(X)
\end{array}$$

for all $\lambda \in \mathbb{C}$, where τ is the complex number in (2.3). Note that since $T \in \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$, it follows that the image of Φ lies in $\operatorname{Aut}(\operatorname{Pic}^0(X))_0 = \operatorname{Pic}^0(X) \subset \operatorname{Aut}(\operatorname{Pic}^0(X))$. Thus, Φ is a constant map, again because there is no nonconstant algebraic map from \mathbb{C} to $\operatorname{Pic}^0(X)$. Let

$$\widehat{\Phi} = \Phi(\mathbb{C}) \in \operatorname{Pic}^{0}(X) \tag{2.5}$$

be the image of the map Φ .

Let

$$h: \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0 \longrightarrow \operatorname{Pic}^0(X) \times \mathbb{C}^*$$

be the map defined by $T \mapsto (\widehat{\Phi}, \tau)$. It is straight-forward to check that h is a group homomorphism.

We will now show that h is surjective. For this, first note that the multiplicative action of \mathbb{C}^* on \mathbb{C} has a natural lift to an action of \mathbb{C}^* on \mathcal{M}_{Hod} . Indeed, any $c \in \mathbb{C}^*$ acts on \mathcal{M}_{Hod} as

$$(\lambda, L, D) \longmapsto (c \cdot \lambda, L, c \cdot D).$$

For all these automorphisms of \mathcal{M}_{Hod} given by the action of \mathbb{C}^* , the corresponding elements of $\text{Pic}^0(X)$ (see (2.5)) coincide with the identity element. Therefore, to prove that h is surjective, it suffices to show that the composition of h with the projection $\text{Pic}^0(X) \times \mathbb{C}^* \longrightarrow \text{Pic}^0(X)$ is surjective. Take any $L_0 \in \text{Pic}^0(X)$ and fix a holomorphic connection D_0 on L_0 . Define

$$\beta\colon \mathcal{M}_{\mathrm{Hod}} \longrightarrow \mathcal{M}_{\mathrm{Hod}}, \qquad (\lambda, L, D) \longmapsto (\lambda, L \otimes L_0, (D \otimes \mathrm{Id}_{L_0}) + (\lambda \cdot \mathrm{Id}_L \otimes D_0)).$$

It is straight-forward to check that $\beta \in \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})$; its inverse is the corresponding map for (L_0^*, D_0^*) . Since the moduli space of rank one connections on X is connected, it follows that $\beta \in \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$; note that β for the trivial connection (\mathcal{O}_X, d) is the identity map of $\mathcal{M}_{\operatorname{Hod}}$. The element in $\operatorname{Pic}^0(X)$ corresponding to β (see (2.5)) is clearly L_0 . Therefore, the composition of h with the projection $\operatorname{Pic}^0(X) \times \mathbb{C}^* \longrightarrow \operatorname{Pic}^0(X)$ and hence h itself are surjective.

Next, we need to define $\mathbb{V} \xrightarrow{\iota} \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$. To do so, consider for $v \in \mathbb{V}$ the automorphism

$$\iota_v \colon \mathcal{M}_{\mathrm{Hod}} \longrightarrow \mathcal{M}_{\mathrm{Hod}}, \qquad (\lambda, L, D) \longmapsto (\lambda, L, D + v(\lambda)).$$
 (2.6)

Clearly, we have $\iota_v \in \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$, and also $\iota_v \in \operatorname{kernel}(h)$. Therefore, there is an injective homomorphism

$$\iota \colon \mathbb{V} \longrightarrow \operatorname{kernel}(h) \subset \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0, \qquad v \longmapsto \iota_v.$$

We will prove that $image(\iota) = kernel(h)$.

In order to prove that $\operatorname{image}(\iota) = \operatorname{kernel}(h)$, take any $T \in \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$ such that

$$T \in \operatorname{kernel}(h).$$

We have $T(f^{\lambda}) = f^{\lambda}$ for all $\lambda \in \mathbb{C}^*$ because the constant in (2.3) for T is 1. Since the element in (2.5) corresponding to T is the trivial line bundle, we get a morphism

 $\delta_{\lambda}: f^{\lambda} \longrightarrow H^0(X, K_X), \qquad z \longmapsto T(z) - z;$

note that since the fibers of ϕ^{λ} (constructed in (2.4)) are affine spaces for $H^0(X, K_X)$, and $\phi^{\lambda}(T(z)) = \phi^{\lambda}(z)$ for all $z \in f^{\lambda}$, we have $T(z) - z \in H^0(X, K_X)$. As there are no nonconstant algebraic functions on f^{λ} [3, Proposition 2.2], it follows that the above function δ_{λ} is a constant one.

All automorphism of the affine space $H^0(X, K_X)$ are of the form $u \mapsto A(u) + u_0$, where $A \in \operatorname{GL}(H^0(X, K_X))$ and $u_0 \in H^0(X, K_X)$. Considering the restrictions of T to open subsets of the form $h^{-1}(V \times U)$, where U is an analytic neighborhood of $0 \in \mathbb{C}$ and V is an analytic open subset of $\operatorname{Pic}^0(X)$, it now follows that the above map

$$\lambda \mapsto \operatorname{image}(\delta_{\lambda}) \in H^0(X, K_X)$$

extends across $0 \in \mathbb{C}$ as a holomorphic map from \mathbb{C} to $H^0(X, K_X)$. In other words, there is a unique element $v \in \mathbb{V}$ such that $v(\lambda) = \operatorname{image}(\delta_{\lambda})$ for all $\lambda \in \mathbb{C}^*$. Clearly, we have $\iota_v = T$, where ι_v is constructed in (2.6). This implies that $\operatorname{image}(\iota) = \operatorname{kernel}(h)$. This completes the proof of the theorem.

2.2 Automorphisms preserving a cohomology class

In this subsection we assume that g = genus(X) > 1.

Since any holomorphic line bundle of degree zero on the compact Riemann surface X admits a unique flat connection with unitary monodromy, the Picard group $\operatorname{Pic}^{0}(X)$ is identified with

$$\operatorname{Hom}(\pi_1(X), \operatorname{U}(1)) = \operatorname{Hom}(H_1(X, \mathbb{Z}), \operatorname{U}(1)).$$

There is a natural symplectic form

$$\widetilde{ heta}$$
 (2.7)

on the character variety $\operatorname{Hom}(\pi_1(X), \operatorname{U}(1))$ [1, 6]. The cohomology class defined by $\tilde{\theta}$ is integral. Let

$$\theta_0 \in H^2(\operatorname{Pic}^0(X), \mathbb{Z})$$

be the cohomology class given by $\tilde{\theta}$ in (2.7). This θ_0 is a principal polarization on $\operatorname{Pic}^0(X)$. More precisely, it is the class of a theta divisor on $\operatorname{Pic}^0(X)$. Consider the projection

$$\phi: \mathcal{M}_{\mathrm{Hod}} \longrightarrow \mathrm{Pic}^{0}(X), \qquad (\lambda, L, D) \longmapsto L;$$

$$(2.8)$$

so, the restriction of ϕ to f^{λ} is the map ϕ^{λ} in (2.4). Define the cohomology class

$$\theta := \phi^* \theta_0 = [\phi^* \tilde{\theta}] \in H^2(\mathcal{M}_{\mathrm{Hod}}, \mathbb{Z}).$$
(2.9)

The moduli space f^1 of holomorphic rank one connections (see (2.2)) has a natural holomorphic symplectic form θ_h . The restriction of θ_h to the moduli space of holomorphic connections $\operatorname{Hom}(\pi_1(X), \operatorname{U}(1))$ with unitary monodromy coincides with the above symplectic form $\tilde{\theta}$. On the other hand f^1 has a deformation retraction onto $\operatorname{Hom}(\pi_1(X), \operatorname{U}(1))$; for example such a deformation retraction is given by a deformation retraction of \mathbb{C}^* to $\operatorname{U}(1)$. Therefore, we conclude that the cohomology class of θ_h coincides with the restriction of θ to f^1 .

Let

$$\operatorname{Aut}^{\theta}(\mathcal{M}_{\operatorname{Hod}}) \subset \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})$$
(2.10)

be the subgroup consisting of all algebraic automorphisms of \mathcal{M}_{Hod} that fixes the cohomology class θ in (2.9).

Let $\operatorname{Aut}(X)$ denote the group of all holomorphic automorphisms of X. We have a homomorphism

$$\mu\colon \operatorname{Aut}(X) \oplus (\mathbb{Z}/2\mathbb{Z}) \longrightarrow \operatorname{Aut}\left(\operatorname{Pic}^{0}(X)\right), \qquad \mu(t,0)(L) = t^{*}L, \qquad \mu(t,1)(L) = t^{*}L^{*}.$$

We note that the restriction $\mu|_{\operatorname{Aut}(X)}$ is injective (recall that $g \ge 2$), and μ is injective if and only if X is non-hyperelliptic. If X is hyperelliptic, then the hyperelliptic involution acts on $\operatorname{Pic}^{0}(X)$ as $L \longmapsto L^{*}$. Define

$$\Gamma_X = \text{image}(\mu). \tag{2.11}$$

So, $\Gamma_X = \operatorname{Aut}(X)$ if X is hyperelliptic, and $\Gamma_X = \operatorname{Aut}(X) \oplus (\mathbb{Z}/2\mathbb{Z})$ if X is non-hyperelliptic. We also have a homomorphism

$$\widetilde{\mu}: \operatorname{Aut}(X) \oplus (\mathbb{Z}/2\mathbb{Z}) \longrightarrow \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})$$
(2.12)

defined by $\tilde{\mu}(t,0)(\lambda, L, D) = (\lambda, t^*L, t^*D)$ and $\tilde{\mu}(t,1)(\lambda, L, D) = (\lambda, t^*L^*, t^*D^*)$. Note that if $\lambda = 0$, then $D^* = -D \in H^0(X, K_X)$. The homomorphism $\tilde{\mu}$ in (2.12) factors through the quotient Γ_X of Aut $(X) \oplus (\mathbb{Z}/2\mathbb{Z})$ in (2.11).

Consider the action of Γ_X on Aut(\mathcal{M}_{Hod}) given by the composition of $\tilde{\mu}$ with the adjoint action of Aut(\mathcal{M}_{Hod}) on itself. This action preserves the connected component Aut(\mathcal{M}_{Hod})₀. Define the semi-direct product

$$\Gamma_X := \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0 \rtimes \Gamma_X \tag{2.13}$$

for the above action of Γ_X on $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$.

Consider the action of Γ_X on \mathcal{M}_{Hod} given by $\tilde{\mu}$ in (2.12). This action clearly fixes the cohomology class θ in (2.9). The action of $\text{Aut}(\mathcal{M}_{\text{Hod}})_0$ on \mathcal{M}_{Hod} fixes θ because $\text{Aut}(\mathcal{M}_{\text{Hod}})_0$ is connected. Also, $\text{Aut}(\mathcal{M}_{\text{Hod}})_0$ is a normal subgroup of $\text{Aut}(\mathcal{M}_{\text{Hod}})$. Therefore, we get a homomorphism

$$\rho\colon \widetilde{\Gamma}_X \longrightarrow \operatorname{Aut}^{\theta}(\mathcal{M}_{\operatorname{Hod}}), \tag{2.14}$$

where $\operatorname{Aut}^{\theta}(\mathcal{M}_{\operatorname{Hod}})$ and $\widetilde{\Gamma}_X$ are constructed in (2.10) and (2.13) respectively.

Proposition 2.3. The homomorphism ρ in (2.14) is an isomorphism.

Proof. We will first prove that ρ is injective. For this note that ϕ in (2.8) induces an isomorphism of first cohomologies with coefficients in \mathbb{C} . Indeed, the fibers of ϕ are diffeomorphic to $\mathbb{C} \times H^0(X, K_X)$, hence ϕ induces an isomorphism $H^1(\operatorname{Pic}^0(X), \mathbb{C}) \xrightarrow{\phi^*} H^1(\mathcal{M}_{\operatorname{Hod}}, \mathbb{C})$. Take any

$$\gamma \in \operatorname{kernel}(\rho) \subset \Gamma_X.$$

Let $\gamma' \in \Gamma_X$ be the image of γ by the natural projection of $\widetilde{\Gamma}_X$ to Γ_X . Let $\gamma'' \in \widetilde{\Gamma}_X$ be the image of γ' by the natural inclusion $\Gamma_X \hookrightarrow \widetilde{\Gamma}_X$. So, γ and γ'' differ by an element of $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$. Since γ acts trivially on $H^1(\mathcal{M}_{\operatorname{Hod}}, \mathbb{C})$ (as it acts trivially on $\mathcal{M}_{\operatorname{Hod}}$), and $\operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$ acts trivially on $H^1(\mathcal{M}_{\operatorname{Hod}}, \mathbb{C})$ as it is connected, we conclude that γ'' acts trivially on $H^1(\mathcal{M}_{\operatorname{Hod}}, \mathbb{C})$. This implies that γ' acts trivially on $H^1(\operatorname{Pic}^0(X), \mathbb{C}) = H^1(\mathcal{M}_{\operatorname{Hod}}, \mathbb{C})$. But, as noted earlier, this implies that $\gamma' = 1$. Hence, $\gamma \in \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$. Now we conclude that $\gamma = 1$ because $\rho(\gamma)$ is the trivial automorphism of $\mathcal{M}_{\operatorname{Hod}}$. Hence ρ is injective.

Let $T \in \operatorname{Aut}^{\theta}(\mathcal{M}_{\operatorname{Hod}})$. The image

$$T(\{0\} \times \operatorname{Pic}^{0}(X) \times \{0\}) \subset \mathcal{M}_{\operatorname{Hod}}$$

is of the form

 $\{0\} \times \operatorname{Pic}^0(X) \times \{\omega\}$

for some $\omega \in H^0(X; K_X)$, as can be deduced analogously to the proof of Theorem 2.2. By applying a suitable automorphism $T_0 \in \operatorname{Aut}(\mathcal{M}_{\operatorname{Hod}})_0$ we get

$$T_0 \circ T(\{0\} \times \operatorname{Pic}^0(X) \times \{0\}) = \{0\} \times \operatorname{Pic}^0(X) \times \{0\}.$$

The group of automorphisms of the abelian variety $\operatorname{Pic}^{0}(X)$ that fix the principal polarization θ_{0} is generated by Γ_{X} and the translations of $\operatorname{Pic}^{0}(X)$ (see [14, p. 35, Hauptsatz]). Because of the discussion in the beginning of Section 2.2 it follows that we can apply an automorphism $T_{1} \in \Gamma_{X}$ such that

$$T_1 \circ T_0 \circ T$$

is the identity whence restricted to $\{0\} \times \operatorname{Pic}^0(X) \times \{0\}$. Clearly, this implies first that $T_1 \circ T_0 \circ T$ restricted to f^0 is homotopic to the identity and finally that $T_1 \circ T_0 \circ T$ is homotopic to the identity, which finishes the proof.

3 Holomorphic automorphisms of the Deligne–Hitchin moduli space

3.1 Connected component of the holomorphic automorphism group

The smooth locus of the moduli space of flat connections on a compact Riemann surface is equipped with a natural hyper-Kähler structure; see [8] for the case of $SL(2, \mathbb{C})$ -connections, and [7] for a detailed treatment of the case of flat line bundles.

A hyper-Kähler manifold is a Riemannian manifold (M, g) which is Kähler for three complex structures I, J and K satisfying the quaternionic relations

$$IJ = -JI = K$$

The interplay between the Riemannian, symplectic and complex geometric aspects of hyper-Kähler manifolds makes them fascinating mathematical objects. A hyper-Kähler manifold M admits a twistor space which contains all of the information about M in a complex geometric fashion: The compatible complex structures on M are parametrized by $\mathbb{C}P^1 = S^2 = \{(x_1, x_2, x_3) \in \mathbb{R}^3 | x_1^2 + x_2^2 + x_3^2 = 1\}$ via

$$(x_1, x_2, x_3) \longmapsto I_{(x_1, x_2, x_3)} = x_1 I + x_2 J + x_3 K,$$

where I, J, K are the three original complex structures on M. The twistor space \mathcal{Z} is a complex manifold with a holomorphic surjective submersion to $\mathbb{C}P^1$ such that the fiber over every $z \in \mathbb{C}P^1$ is identified with (M, I_z) . The twistor lines are the "constant" sections of the above fibration $\mathcal{Z} = M \times \mathbb{C}P^1 \longrightarrow \mathbb{C}P^1$. These sections are holomorphic and the normal bundle of a twistor line is isomorphic to $\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus d} \longrightarrow \mathbb{C}P^1$, where $d = \frac{1}{2} \dim_{\mathbb{R}} M$. This normal bundle is equipped with additional structures which provide all of the information needed to reconstruct the hyper-Kähler structure on M; see [9] for details.

For a complex reductive group $G_{\mathbb{C}}$, the hyper-Kähler structure on the moduli space of flat $G_{\mathbb{C}}$ -connections on a compact Riemann surface X is given by non-abelian Hodge theory. The complex structure J is induced by the complex Lie group $G_{\mathbb{C}}$ through the identification of the moduli space with the Betti moduli space $\operatorname{Hom}(\pi_1(X), G_{\mathbb{C}})/\!\!/G_{\mathbb{C}}$. Via the solutions of Hitchin's self-duality equation, the moduli space of stable $G_{\mathbb{C}}$ -Higgs bundles, i.e., the Dolbeault moduli space, gets identified with the moduli space of irreducible flat connections, yielding the complex structure I. The reverse map $\mathcal{M}_{dR} \longrightarrow \mathcal{M}_{Dol}$ arises from Donaldson's twisted harmonic maps construction [5] for the case of $G_{\mathbb{C}} = \operatorname{SL}(2, \mathbb{C})$, see [4] for the general case. It was first shown by Hitchin in the case of $\operatorname{SL}(2, \mathbb{C})$ that I, J and K := IJ give rise to a hyper-Kähler structure for the natural Riemannian metric. In the abelian case of $G_{\mathbb{C}} = \mathbb{C}^*$ the theory simplifies considerably boiling down to the classical abelian Hodge theory [7].

It was first noticed by Deligne that the twistor space of the moduli space of flat connections on a Riemann surface X has a convenient description by gluing the Hodge moduli spaces for X and \overline{X} via the Riemann-Hilbert isomorphism; see [11, 12] for details. We recall below this construction for the rank one case (the case of our interests).

Take a point $(\lambda, L, D) \in \mathcal{M}_{Hod}(X) = \mathcal{M}_{Hod}^X(1)$ with $\lambda \neq 0$ and consider the flat connection D/λ on L. Let

$$\rho \colon \pi_1(X) \longrightarrow H^1(X,\mathbb{Z}) \longrightarrow \mathbb{C}^*$$

be the monodromy representation for D/λ . After identifying $H^1(X,\mathbb{Z})$ with $H^1(\overline{X},\mathbb{Z})$ by the identity map of the underlying C^{∞} manifolds, the homomorphism ρ gives a holomorphic rank one 1-connection $(1, E, \widetilde{D})$ on \overline{X} . Consider the morphism f in (2.1). Let

$$f_{\overline{X}}: \ \mathcal{M}_{\mathrm{Hod}}(\overline{X}) := \mathcal{M}_{\mathrm{Hod}}^{\overline{X}}(1) \longrightarrow \mathbb{C}$$

be the morphism obtained by substituting \overline{X} in place of X in (2.1). Define a holomorphic map

$$\varphi \colon f^{-1}(\mathbb{C}^*) \longrightarrow f^{-1}_{\overline{X}}(\mathbb{C}^*), \qquad (\lambda, L, D) \longmapsto \left(\lambda^{-1}, E, \widetilde{D}/\lambda\right)$$
(3.1)

of the restrictions of the fiber bundles $\mathcal{M}_{Hod}(X)$ and $\mathcal{M}_{Hod}(\overline{X})$ to $\mathbb{C}^* \subset \mathbb{C}$. This φ is clearly a biholomorphism.

Definition 3.1. The rank one Deligne–Hitchin moduli space

 $\mathcal{M}_{\mathrm{DH}} = \mathcal{M}_{\mathrm{DH}}(X)$

is

$$\mathcal{M}_{\mathrm{DH}}(X) = \mathcal{M}_{\mathrm{Hod}}(X) \cup_{\varphi} \mathcal{M}_{\mathrm{Hod}}(\overline{X}).$$

We note that the map $f|_{f^{-1}(\mathbb{C}^*)}$ coincides with the composition

$$f^{-1}(\mathbb{C}^*) \xrightarrow{\varphi} f_{\overline{X}}^{-1}(\mathbb{C}^*) \xrightarrow{f_{\overline{X}}} \mathbb{C}^* \xrightarrow{z \mapsto z^{-1}} \mathbb{C}^*.$$

Therefore, f and the composition

$$\mathcal{M}_{\mathrm{Hod}}(\overline{X}) \xrightarrow{f_{\overline{X}}} \mathbb{C} \xrightarrow{z \mapsto z^{-1}} \mathbb{C}P^1 \setminus \{0\}$$

patch together to produce a morphism

$$f: \mathcal{M}_{\rm DH} \longrightarrow \mathbb{C}P^1. \tag{3.2}$$

For any $\lambda \in \mathbb{C}P^1$, the fiber $f^{-1}(\lambda)$ will be denoted by f^{λ} . The fiber f^{∞} is the moduli space of Higgs line bundles of degree zero on \overline{X} . This f is the twistor fibration mentioned earlier.

Definition 3.2. The *degree* of a smooth map $i: \Sigma \longrightarrow \mathcal{M}_{DH}(X)$ from a compact oriented surface Σ is the degree of the composition $f \circ i: \Sigma \longrightarrow \mathbb{C}P^1$, where f is the projection in (3.2).

Lemma 3.3. Let Σ be a compact Riemann surface of genus g_{Σ} and $i: \Sigma \longrightarrow \mathcal{M}_{DH}(X)$ be a holomorphic immersion. Then the degree of the corresponding holomorphic normal bundle

$$\mathcal{N} = (i^* T \mathcal{M}_{\rm DH}) / T \Sigma$$

is

$$\deg(\mathcal{N}) = (2g_X + 2)\deg(i) - \deg(T\Sigma) = (2g_X + 2)\deg(i) + 2g_\Sigma - 2,$$

where g_X is the genus of X.

Proof. As in the computation in [9, pp. 555–556] it can be shown that the tangent bundle of the complex manifold \mathcal{M}_{DH} is holomorphically isomorphic to the pull-back

$$f^*(\mathcal{O}_{\mathbb{C}P^1}(2)\oplus (\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g_X})),$$

where the first summand is the tangent bundle of $\mathbb{C}P^1$ and the direct sum $\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g_X}$ corresponds to the hyper-Kähler structure on \mathcal{M}_{dR} . Now the lemma follows immediately from the fact that degree $(i^*f^*\mathcal{O}_{\mathbb{C}P^1}(1)) = \text{degree}(i)$.

We will compute $\operatorname{Aut}(\mathcal{M}_{DH})_0$ by proving a series of lemmas.

Lemma 3.4. Let $\alpha, \beta, \omega, \eta \in H^0(X, K_X)$ be holomorphic 1-forms. There exists a holomorphic section $s \colon \mathbb{C}P^1 \longrightarrow \mathcal{M}_{DH}$ defined by

$$s(\lambda) = [\lambda, \overline{\partial} + \overline{\omega} + \lambda \overline{\eta}, \lambda(\partial + \alpha) + \beta] \in \mathcal{M}_{\mathrm{Hod}}(X) \subset \mathcal{M}_{\mathrm{DH}}$$

for $\lambda \in \mathbb{C} \subset \mathbb{C}P^1$. Conversely, every section of $f: \mathcal{M}_{DH} \longrightarrow \mathbb{C}P^1$ is of this form.

Proof. The first part of the lemma is easily verified. In order to prove the converse direction we start with a lift of the family of holomorphic structures on $\mathbb{C} \subset \mathbb{C}P^1$: As \mathbb{C} is simply connected, there exists a map

$$\lambda \longmapsto \overline{\omega}_1(\lambda) \in \overline{H^0(X, K_X)}, \qquad \lambda \in \mathbb{C}$$

such that

$$\phi \circ s(\lambda) = [\overline{\partial} + \overline{\omega}_1(\lambda)]$$

for all $\lambda \in \mathbb{C}$, where ϕ is the projection in (2.8) and [-] denotes gauge equivalence class. Let $\beta \in H^0(X, K_X)$ be the (well-defined) Higgs field of s(0). A lift of s is then given by

$$\widehat{s}(\lambda) = (\lambda, \overline{\partial} + \overline{\omega}_1(\lambda), \beta + \lambda(\partial + \alpha_1(\lambda)))$$

for some holomorphic map

$$\alpha_1 \colon \mathbb{C} \longrightarrow \Omega^{(1,0)}(X).$$

The image of α_1 is contained in $H^0(X, K_X) \subset \Omega^{(1,0)}(X)$ because the λ -connections are integrable. Thus, $\lambda \longmapsto s(\lambda), \lambda \in \mathbb{C}^*$, produces the following family of flat connections on X:

$$\widehat{\nabla}^{\lambda} = d + \lambda^{-1}\beta + \overline{\omega}_1(\lambda) + \alpha_1(\lambda).$$

We can repeat this over $\mathbb{C}P^1 \setminus \{0\}$ for the Riemann surface \overline{X} . Indeed, there exists a lift \tilde{s} of the form

$$\widetilde{s}(\mu) = (\mu, \partial + \alpha_2(\mu), \mu(\overline{\partial} + \overline{\omega}_2(\mu)) + \overline{\eta})$$

with $\mu = \frac{1}{\lambda}$. The corresponding flat connections are denoted by $\widetilde{\nabla}^{\lambda}$. By the gluing condition in Definition 3.1 there exists a gauge transformation $g(\lambda): X \longrightarrow \mathbb{C}^*$ for every $\lambda \in \mathbb{C}^*$ such that

$$\widehat{\nabla}^{\lambda} \cdot g(\lambda) = \widetilde{\nabla}^{\lambda};$$

this gauge transformation is unique up to a constant scalar. Since the connection 1-forms of $\widehat{\nabla}^{\lambda}$ and $\widetilde{\nabla}^{\lambda}$ are both harmonic 1-forms, their difference

$$\widehat{\nabla}^{\lambda} - \widetilde{\nabla}^{\lambda} = \chi(\lambda)$$

is a lattice point

$$\chi(\lambda) \in \Lambda := \bigg\{ \chi \in \Omega^1(X, \mathbb{C}) \, | \, d\chi = d * \chi = 0; \, \int_{\gamma} \chi \in 2\pi \sqrt{-1}\mathbb{Z} \text{ for all closed curves } \gamma \bigg\}.(3.3)$$

As the connection 1-forms depend continuously on λ , it follows that χ is independent of λ . By construction, the connection 1-form of $\lambda \mapsto \widetilde{\nabla}^{\lambda}$ has a first order pole at $\lambda = \infty$ whose residue is $\overline{\eta}$. This implies that $\overline{\omega}_1(\lambda)$ must be a polynomial of degree at most one and that $\alpha_1(\lambda)$ is a constant α .

Lemma 3.5. Let $T: \mathcal{M}_{DH} \longrightarrow \mathcal{M}_{DH}$ be a holomorphic automorphism. Then T maps fibers of f to fibers of f. Moreover, it covers the automorphism $\lambda \mapsto \tau \lambda$ or $\lambda \mapsto \frac{\tau}{\lambda}$ of $\mathbb{C}P^1$ for some $\tau \in \mathbb{C}^*$; if the latter case occurs, then the Jacobian of X is isomorphic to the Jacobian of \overline{X} .

Proof. We first prove that two points in the same fiber $p_1, p_2 \in f^{\lambda_0} = f^{-1}(\lambda_0)$ are mapped by T into a single fiber f^{λ_1} . To this end, we claim that any two points p_1, p_2 in different fibers can be joined by a holomorphic section $\mathbb{C}P^1 \longrightarrow \mathcal{M}_{\text{DH}}$ of the map f. This can be proved quite easily by linear interpolation with sections of the form given in Lemma 3.4.

If two points x_1 , x_2 of one fiber of f are mapped by T into two different fibers of f, we consider a holomorphic section s of f passing through $T(x_1)$ and $T(x_2)$. Then $\lambda \mapsto T^{-1}(s(\lambda))$ is a holomorphic immersion of $\mathbb{C}P^1$ to \mathcal{M}_{DH} , and the degree of its normal bundle is the same as the degree of the normal bundle of the section s. From Lemma 3.3 we obtain

$$(2g_X + 2)\deg(i) - 2 = 2g_X,$$

which yields deg(i) = 1. On the other hand, its degree is at least two because it passes through two points x_1 , x_2 lying in one fiber. In view of this contradiction we conclude that T maps fibers of f to fibers of f.

Therefore, there is a unique holomorphic map

$$T'\colon \mathbb{C}P^1 \longrightarrow \mathbb{C}P^1$$

such that $f \circ T = T' \circ f$. As in the proof of Theorem 2.2, T must satisfy $T(\{0, \infty\}) = \{0, \infty\}$, and hence T' is of the form $\lambda \mapsto \tau \lambda$ or $\lambda \mapsto \frac{\tau}{\lambda}$ for some $\tau \in \mathbb{C}^*$. If $T(0) = \infty$ the rank one Higgs moduli spaces for X and \overline{X} are holomorphically isomorphic. Since there is no nonconstant holomorphic map from an abelian variety to an affine space, any biholomorphism between the rank one Higgs moduli spaces for X and \overline{X} produces a biholomorphism between $\operatorname{Pic}^0(X)$ and $\operatorname{Pic}^0(\overline{X})$.

Let $T: \mathcal{M}_{DH} \longrightarrow \mathcal{M}_{DH}$ be a holomorphic automorphism that maps each fiber of f to itself, meaning $T(f^{\lambda}) = f^{\lambda}$ for all $\lambda \in \mathbb{C}P^1$. Consider the projection

$$\pi_2: f^0 = \operatorname{Pic}^0(X) \times H^0(X, K_X) \longrightarrow H^0(X, K_X).$$
(3.4)

Then, the automorphism T restricted to f^0 maps fibers of π_2 to fibers of π_2 since $\operatorname{Pic}^0(X)$ does not have any nonconstant holomorphic map to $H^0(X, K_X)$. A corresponding statement is true for the fiber f^{∞} . Thus, the assumptions in the following lemma are natural.

Lemma 3.6. Let $T: \mathcal{M}_{DH} \longrightarrow \mathcal{M}_{DH}$ be a holomorphic automorphism such that $T(f^{\lambda}) = f^{\lambda}$ for all $\lambda \in \mathbb{C}P^1$. Assume that T restricted to $\operatorname{Pic}^0(X) \times \{0\} \subset f^0$ is the identity map, and Trestricted to $\operatorname{Pic}^0(\overline{X}) \times \{0\} \subset f^{\infty}$ is the identity map. Then, there exists an integral harmonic 1-form $\gamma \in \Lambda = H^1(X, \mathbb{Z}) \subset \operatorname{Harm}(X; \mathbb{C})$ such that T is given by

$$T((\lambda, E, D)) = (\lambda, E, D + \lambda \gamma'),$$

where $\gamma = \gamma' + \gamma''$ is the decomposition into (1,0) and (0,1) components.

Proof. Consider the "constant" section of f

$$s(\lambda) = [\lambda, \partial, \lambda\partial],$$

where $d = \partial + \overline{\partial}$ is the decomposition into types. From Lemma 3.4 and the assumption that T restricted to $\text{Pic}^0(X) \times \{0\} \subset f^0$ is the identity map it follows that $T \circ s$ must be of the form

$$T \circ s(\lambda) = (\lambda, \overline{\partial} + \gamma_1'', \lambda(\partial + \gamma_2')) \tag{3.5}$$

for some $\gamma_1, \gamma_2 \in \Lambda$. By applying the gauge exp $\left(-\int \gamma_1\right)$, the identity in (3.5) is equivalent to

$$T \circ s(\lambda) = (\lambda, \overline{\partial}, \lambda(\partial + \gamma'))$$

for $\gamma = \gamma_2 - \gamma_1$.

Since T is continuous it follows that for every constant section of f defined by $s_D(\lambda) = (\lambda, L, \lambda D)$, where D is a holomorphic connection on L, the equality

$$T \circ s_D(\lambda) = (\lambda, L, \lambda(D + \gamma'))$$

holds. It should be mentioned that this is equivalent to

$$T \circ s(\lambda) = (\lambda, L \otimes L(\overline{\partial} - \gamma''), \lambda D).$$

Note that for any $\lambda \in \mathbb{C} \setminus \{0\}$ and for every point $p = (\lambda, E, D) \in f^{\lambda}$, there exists a constant section which goes through p. This completes the proof.

Let

s:
$$\mathbb{C}P^1 \longrightarrow \mathcal{M}_{\mathrm{DH}}, \qquad \lambda \longmapsto [\lambda, \overline{\partial} + \overline{\omega} + \lambda \overline{\eta}, \lambda(\partial + \alpha) + \beta]$$

be a section of f, where $\alpha, \beta, \eta, \omega \in H^0(X, K_X)$; define

$$T_s: \mathcal{M}_{\mathrm{DH}} \longrightarrow \mathcal{M}_{\mathrm{DH}}, \qquad [\lambda, E, D] \longmapsto [\lambda, E \otimes L(\overline{\partial} + \overline{\omega} + \lambda \overline{\eta}), D \otimes (\lambda(\partial + \alpha) + \beta)], \quad (3.6)$$

where the tensor product of two λ -connections D, \tilde{D} on two holomorphic line bundles E, \tilde{E} respectively is the λ -connection

$$D \otimes \widetilde{D}(e \otimes \widetilde{e}) = D(e) \otimes \widetilde{e} + e \otimes \widetilde{D}(\widetilde{e})$$

on $E \otimes \widetilde{E}$. This T_s is clearly a holomorphic automorphism of \mathcal{M}_{DH} . Let

 $\operatorname{Aut}(\mathcal{M}_{\mathrm{DH}})_0 \subset \operatorname{Aut}(\mathcal{M}_{\mathrm{DH}})$

be the connected component, containing the identity element, of the group of holomorphic automorphisms of $\mathcal{M}_{\rm DH}$. Using Lemmas 3.5 and 3.6 we can give the following description of ${\rm Aut}(\mathcal{M}_{\rm DH})_0$.

Theorem 3.7. There is an isomorphism

$$\operatorname{Aut}(\mathcal{M}_{\mathrm{DH}})_0 = \mathcal{M}_{dR}(X) \times \left(\left(H^0(X, K_X) \times \overline{H^0(X, K_X)} \right) \rtimes \mathbb{C}^* \right)$$

with the group structure of the right-hand side given by

$$\left(\nabla^{1},\alpha_{1},\overline{\eta}_{1},\tau_{1}\right)\cdot\left(\nabla^{2},\alpha_{2},\overline{\eta}_{2},\tau_{2}\right)=\left(\nabla^{1}\otimes\nabla^{2},\alpha_{1}+\tau_{1}\alpha_{2},\overline{\eta}_{1}+\frac{1}{\tau_{1}}\overline{\eta}_{2},\tau_{1}\tau_{2}\right).$$
(3.7)

The group $\mathcal{M}_{dR}(X)$ acts via the automorphisms T_s in (3.6), $H^0(X, K_X) \times \overline{H^0(X, K_X)}$ acts using addition of forms to connections and Higgs bundles, and \mathbb{C}^* acts via multiplication.

Proof. Using Lemma 3.5 and the lift of the \mathbb{C}^* action on $\mathbb{C}P^1$ we can restrict to automorphisms $T \in \operatorname{Aut}(\mathcal{M}_{DH})_0$ such that

$$T(f^{\lambda}) = f^{\lambda}$$

for all $\lambda \in \mathbb{C}P^1$. We claim that there exists a section $s: \mathbb{C}P^1 \longrightarrow \mathcal{M}_{DH}$ of f such that $T_s \circ T$ is of the form given in Lemma 3.6, where T_s is constructed in (3.6).

Recall that T acts fiberwise on the fibers of π_2 in (3.4). An automorphism of $\operatorname{Pic}^0(X)$ which is homotopic to the identity map is a translation by an element of $\operatorname{Pic}^0(X)$. Hence, there exists $\alpha, \omega \in H^0(X, K_X)$ such that

$$T(0, L, 0) = (0, L \otimes L(\overline{\partial} + \overline{\omega}), \alpha)$$

for all $(0, L, 0) \in \pi_2^{-1}(0) \subset f^0$. The same argument yields that there are $\beta, \eta \in H^0(X, K_X)$ such that the automorphism T_s , for the section s defined by

 $s(\lambda) = (\lambda, \overline{\partial} - \overline{\omega} - \lambda \overline{\eta}, \lambda(\partial - \beta) - \alpha),$

has the desired properties.

Moreover, by applying the arguments in the proof of Lemma 3.6, we see that a section s of f such that $T_s \circ T$ is of the form given in Lemma 3.6 is unique up to tensoring with a constant section of the form $\lambda \longmapsto (\lambda, \overline{\partial}, \lambda(\partial + \gamma'))$ for some $\gamma \in H^1(X, \mathbb{Z}) \subset \operatorname{Harm}(X, \mathbb{C})$.

Altogether, we obtain that any element in $\operatorname{Aut}(\mathcal{M}_{DH})_0$ is of the form $(\nabla, \alpha, \overline{\eta}, \tau) \in \mathcal{M}_{dR}(X) \times ((H^0(X, K_X) \times \overline{H^0(X, K_X)}) \rtimes \mathbb{C}^*)$ for the actions of the components $\mathcal{M}_{dR}(X)$, $H^0(X, K_X)$, $\overline{H^0(X, K_X)}$ and \mathbb{C}^* on \mathcal{M}_{DH} as described above. The group structure of $\operatorname{Aut}(\mathcal{M}_{DH})_0$ is easily verified to be as in (3.7).

3.2 Automorphisms of \mathcal{M}_{DH} preserving a cohomology class

In this subsection we assume that g = genus(X) > 1.

Till now we have restricted to automorphism of \mathcal{M}_{DH} lying in Aut $(\mathcal{M}_{DH})_0$. In this subsection we define a natural cohomology class on \mathcal{M}_{DH} and compute all automorphisms which preserve this particular class.

Any holomorphic automorphism $t: X \longrightarrow X$ induces an automorphism $T_t: \mathcal{M}_{DH} \longrightarrow \mathcal{M}_{DH}$ via pull-back; note that t is also a holomorphic automorphism of \overline{X} . More precisely, for $\lambda \in \mathbb{C}^*$ and $(\lambda, L, D) \in f^{\lambda}$, define

$$T_t(\lambda, L, D) = (\lambda, t^*L, t^*D).$$
(3.8)

It is straight-forward to check that (3.8) extends holomorphically to f^0 and f^{∞} giving rise to a holomorphic automorphism of \mathcal{M}_{DH} ; the inverse of T_t is $T_{t^{-1}}$. Similarly, if

$$s: \overline{X} \longrightarrow X$$

is a holomorphic isomorphism, then define

$$T_s: \mathcal{M}_{\mathrm{Hod}}(X) \longrightarrow \mathcal{M}_{\mathrm{Hod}}(\overline{X}), \qquad (\lambda, L, D) \longmapsto (\lambda, s^*L, s^*D).$$

But $\mathcal{M}_{\text{Hod}}(\overline{X})$ is identified with $\mathcal{M}_{\text{DH}} \setminus f^0$ (this follows immediately from (3.1)). Therefore, T_s gives a biholomorphism of $\mathcal{M}_{\text{Hod}}(X)$ with $\mathcal{M}_{\text{DH}} \setminus f^0$. This biholomorphism extends f^{∞} , and hence T_s is a holomorphic automorphism of \mathcal{M}_{DH} over the involution $\lambda \mapsto \frac{1}{\lambda}$ of $\mathbb{C}P^1$. Explicitly, for $\lambda \neq 0, \infty$ it is given by

$$T_s(\lambda, L, D) = \varphi^{-1}((\lambda, s^*L, s^*D)).$$

These examples can be generalized as follows. Consider Λ in (3.3); let Λ'' be its image in $\overline{H^0(X, K_X)} \subset \operatorname{Harm}^1(X; \mathbb{C})$. Then

$$\operatorname{Pic}^{0}(X) = \overline{H^{0}(X, K_{X})} / \Lambda'',$$

$$t: \operatorname{Pic}^{0}(X) \longrightarrow \operatorname{Pic}^{0}(X)$$

with t(0) = 0 gives rise to a map

holomorphic automorphism

$$\widehat{t} = \overline{t} \oplus t \colon H^0(X, K_X) \oplus \overline{H^0(X, K_X)} \longrightarrow H^0(X, K_X) \oplus \overline{H^0(X, K_X)}$$

satisfying

$$\widehat{t}(\Lambda) = \Lambda.$$

Explicitly, \hat{t} is given by

$$\widehat{t}(\alpha \oplus \overline{\eta}) = t(\overline{\alpha}) \oplus t(\overline{\eta})$$

for $\alpha, \eta \in H^0(X, K_X)$. Decompose $d = \partial + \overline{\partial}$. For any $\lambda \in \mathbb{C}^*$, every element $p \in f^{\lambda}$ is of the form

$$p = (\lambda, \overline{\partial} + \overline{\omega}, \lambda(\partial + \alpha))$$

for some $\alpha, \omega \in H^0(X, K_X)$. We then define

$$T(\lambda, \overline{\partial} + \overline{\omega}, \lambda(\partial + \alpha)) = (\lambda, \overline{\partial} + t(\overline{\omega}), \lambda(\partial + \overline{t}(\alpha))).$$
(3.9)

Again, (3.9) yields a well-defined automorphism of \mathcal{M}_{DH} which covers the identity on $\mathbb{C}P^1$. Finally if $s: \operatorname{Pic}^0(X) \longrightarrow \operatorname{Pic}^0(\overline{X})$ is an isomorphism satisfying $s(0) = 0 \in \operatorname{Pic}^0(\overline{X})$, we can construct an off-diagonal isomorphism

$$\widehat{s} = \begin{pmatrix} 0 & s \\ \overline{s} & 0 \end{pmatrix} : \ H^0(X, K_X) \oplus \overline{H^0(X, K_X)} \longrightarrow H^0(X, K_X) \oplus \overline{H^0(X, K_X)}$$

with

$$\widehat{s}(\Lambda) = \Lambda.$$

Thus, the formula

$$T(\lambda,\overline{\partial}+\overline{\omega},\lambda(\partial+\alpha)) = (\lambda,\partial+s(\overline{\omega}),\lambda(\overline{\partial}+\overline{s}(\alpha))) \in \mathcal{M}_{\mathrm{DH}}(\overline{X}) = \mathcal{M}_{\mathrm{DH}}(X)$$
(3.10)

defines an automorphism of $\mathcal{M}_{DH}(X)$ covering $\lambda \longmapsto \lambda^{-1}$.

Proposition 3.8. The components of the space of automorphisms of \mathcal{M}_{DH} are given by the space of holomorphic isomorphisms $t: \operatorname{Pic}^{0}(X) \longrightarrow \operatorname{Pic}^{0}(X)$ with t(0) = 0 together with the space of holomorphic isomorphisms $s: \operatorname{Pic}^{0}(X) \longrightarrow \operatorname{Pic}^{0}(\overline{X})$ with s(0) = 0.

Proof. Let $T: \mathcal{M}_{\mathrm{DH}} \longrightarrow \mathcal{M}_{\mathrm{DH}}$ be a holomorphic automorphism which maps the fiber f^0 to itself. After composing with a suitable element of $\mathrm{Aut}(\mathcal{M}_{\mathrm{DH}})_0$, compare with Section 3.1 and in particular with the proof of Theorem 3.7, we may assume that T maps $\{0\} \times \mathrm{Pic}^0(X) \times \{0\} \subset f^0$ to itself and $\{\infty\} \times \mathrm{Pic}^0(\overline{X}) \times \{0\} \subset f^\infty$ to itself such that $T(0,\overline{\partial},0) = (0,\overline{\partial},0)$ and $T(\infty,\partial,0) =$ $(\infty,\partial,0)$ (where $d = \partial + \overline{\partial}$ as before). We need to show that T is, up to another automorphism in the identity component, of the form (3.9). In view of Lemma 3.6 it remains to prove that the restrictions $t_1: \mathrm{Pic}^0(X) \longrightarrow \mathrm{Pic}^0(X)$ and $t_2: \mathrm{Pic}^0(\overline{X}) \longrightarrow \mathrm{Pic}^0(\overline{X})$ fit together, i.e.,

$$\widehat{t}_1 = t_2 \oplus t_1 \tag{3.11}$$

on $H^0(X, K_X) \oplus \overline{H^0(X, K_X)}$. This follows from an argument similar to one in the proof of Lemma 3.6: First note that constant sections

$$\lambda \longmapsto (\lambda, \overline{\partial} + \overline{\omega}, \lambda(\partial + \alpha))$$

are mapped to constant sections of the form

$$\lambda \longmapsto (\lambda, \overline{\partial} + t_1(\overline{\omega}), \lambda(\partial + t_2(\alpha)))$$

for affine linear lifts $t_1: \overline{H^0(X, K_X)} \longrightarrow \overline{H^0(X, K_X)}$ and $t_2: H^0(X, K_X) \longrightarrow H^0(X, K_X)$ of $t_1: \operatorname{Pic}^0(X) \longrightarrow \operatorname{Pic}^0(X)$ and $t_2: \operatorname{Pic}^0(\overline{X}) \longrightarrow \operatorname{Pic}^0(\overline{X})$. Actually, after applying automorphisms of the form given in Lemma 3.6, we can assume that both lifts are linear. If we apply the above considerations to $\overline{\omega} = \gamma''$ and $\alpha = \gamma'$ where $\gamma = \gamma' + \gamma'' \in \Lambda$ we get that $t_1(\gamma'') \in \Lambda''$, $t_2(\gamma') \in \Lambda'$ and

$$t_2(\gamma') + t_1(\gamma'') \in \Lambda$$

as we have the constant section which goes through the trivial gauge class at $\lambda = 1$. Hence, (3.11) holds and if $\operatorname{Pic}^{0}(X)$ and $\operatorname{Pic}^{0}(\overline{X})$ are not isomorphic the proposition follows from Lemma 3.5.

If $\operatorname{Pic}^{0}(X)$ and $\operatorname{Pic}^{0}(\overline{X})$ are isomorphic, the proposition follows from the first part of the proof together with the observation that (3.10) gives an automorphism of \mathcal{M}_{DH} .

Remark 3.9. We note that $\operatorname{Aut}(\mathcal{M}_{DH})_0$ is a normal subgroup of $\operatorname{Aut}(\mathcal{M}_{DH})$, and the quotient group $\operatorname{Aut}(\mathcal{M}_{DH})/\operatorname{Aut}(\mathcal{M}_{DH})_0$ is identified with the connected components of $\operatorname{Aut}(\mathcal{M}_{DH})$. In particular, the connected components of $\operatorname{Aut}(\mathcal{M}_{DH})$ is also a group. Proposition 3.8 describes the connected components, while Theorem 3.7 describes $\operatorname{Aut}(\mathcal{M}_{DH})_0$. However, these two results do not determine the group structure of $\operatorname{Aut}(\mathcal{M}_{DH})$.

The complex manifold $\mathcal{M}_{DH} = \mathcal{M}_{DH}(X)$ has a natural integer cohomology class $\theta_X \in H^2(\mathcal{M}_{DH},\mathbb{Z})$ which can be constructed as follows: Consider the map ϕ in (2.8). Identify $\operatorname{Pic}^0(X)$ with the character variety $\operatorname{Hom}(\pi_1(X), \operatorname{U}(1))$ as before, and consider ϕ as a map to $\operatorname{Hom}(\pi_1(X), \operatorname{U}(1))$. Let

$$\phi_{\overline{X}}: \mathcal{M}_{\mathrm{Hod}}(\overline{X}) \longrightarrow \mathrm{Hom}(\pi_1(X), \mathrm{U}(1)) = \mathrm{Hom}(\pi_1(\overline{X}), \mathrm{U}(1))$$

be the map obtained by substituting \overline{X} in place of X in the construction of ϕ . The two maps ϕ and $\phi_{\overline{X}}$ coincide over the intersection $\mathcal{M}_{\text{Hod}}(X) \cap \mathcal{M}_{\text{Hod}}(\overline{X}) = f^{-1}(\mathbb{C}^*) \subset \mathcal{M}_{\text{DH}}(X)$. Consequently, we get a map

$$\phi_{\mathrm{DH},X} \colon \mathcal{M}_{\mathrm{DH}}(X) \longrightarrow \mathrm{Hom}(\pi_1(X), \mathrm{U}(1)).$$

Now define

$$\theta_X := \phi_{\mathrm{DH},X}^* \theta_0 \in H^2(\mathcal{M}_{\mathrm{DH}}(X),\mathbb{Z}),$$

where θ_0 is the integral cohomology class in (2.9).

The symplectic form $\hat{\theta}$ on the Hom $(\pi_1(X), \mathrm{U}(1))$ (see (2.9)) depends on the orientation of X, i.e., if the orientation of the topological surface underlying X is changed, then the corresponding symplectic form is $-\tilde{\theta}$. Therefore, with respect to the isomorphism $\mathcal{M}_{\mathrm{DH}}(X) \xrightarrow{\sim} \mathcal{M}_{\mathrm{DH}}(\overline{X})$, we have

$$\theta_X = -\theta_{\overline{X}}$$

where $\theta_{\overline{X}} \in H^2(\mathcal{M}_{DH}(\overline{X}), \mathbb{Z})$ is obtained by substituting \overline{X} in place of X in the construction of θ_X . Let

$$\operatorname{Aut}(\mathcal{M}_{\rm DH}(X))^{\theta_X} \subset \operatorname{Aut}(\mathcal{M}_{\rm DH}(X)) \tag{3.12}$$

be the subgroup that fixes the cohomology class θ_X .

For any holomorphic automorphism $t \in \operatorname{Aut}(\operatorname{Pic}^0(X))$, the corresponding automorphism T_t of $\mathcal{M}_{DH}(X)$ fixes the cohomology class θ_X if and only if

 $t \in \Gamma_X$

(defined in (2.11)); see the proof of Proposition 2.3.

As in Section 2.2 we have an action of Γ_X on $\operatorname{Aut}(\mathcal{M}_{DH})$ which preserves the identity component $\operatorname{Aut}(\mathcal{M}_{DH})_0 \subset \operatorname{Aut}(\mathcal{M}_{DH})$. Consider the corresponding semi-direct product

 $\widetilde{\Gamma}_{\mathrm{DH},X} := \mathrm{Aut}(\mathcal{M}_{\mathrm{DH}})_0 \rtimes \Gamma_X.$

Then, we obtain the following:

Theorem 3.10. The natural homomorphism

$$\Gamma_{\mathrm{DH},X} \longrightarrow \mathrm{Aut}(\mathcal{M}_{\mathrm{DH}}(X))^{\theta_X}$$

where $\operatorname{Aut}(\mathcal{M}_{DH}(X))^{\theta_X}$ is defined in (3.12), is an isomorphism.

Proof. Any holomorphic automorphism of $\mathcal{M}_{DH}(X)$ takes the union $f^0 \cup f^{\infty}$ to itself. Indeed, this follows from the following two facts:

- all compact complex submanifolds of $\mathcal{M}_{DH}(X)$ of dimension at least two are contained in $f^0 \cup f^{\infty}$, and
- the union $f^0 \cup f^\infty$ is covered by compact complex submanifolds of dimension $g \ge 2$.

We next observe that any automorphism $\xi \in \operatorname{Aut}(\mathcal{M}_{DH}(X))^{\theta_X}$ preserves f^0 and f^{∞} individually. To see this, let

$$\xi' \colon f^0 \longrightarrow f^\infty$$

be a biholomorphism. Since the maximal dimensional compact complex submanifolds of f^0 (respectively, f^{∞} are isomorphic to $\operatorname{Pic}^0(X)$ (respectively, $\operatorname{Pic}^0(\overline{X})$), we conclude that ξ' produces a holomorphic isomorphism of $\operatorname{Pic}^0(X)$ with $\operatorname{Pic}^0(\overline{X})$. But the cohomology class of $\tilde{\theta}$ in (2.7) gives a negative class on $\operatorname{Pic}^0(\overline{X})$ after identifying $\operatorname{Pic}^0(\overline{X})$ with $\operatorname{Hom}(\pi_1(X), \operatorname{U}(1)) =$ $\operatorname{Hom}(H_1(X, \mathbb{Z}), \operatorname{U}(1))$. On the other hand, the class $\theta_0 \in H^2(\operatorname{Pic}^0(X), \mathbb{Z})$ given by $\tilde{\theta}$ is ample. A holomorphic isomorphism between complex projective manifolds can't take an ample class to a negative class. Hence any automorphism $\xi \in \operatorname{Aut}(\mathcal{M}_{\mathrm{DH}}(X))^{\theta_X}$ takes f^0 (respectively, f^{∞}) to f^0 (respectively, f^{∞}).

Now the proof is analogous to the proof of Proposition 2.3.

4 Algebraic dimension of the Deligne–Hitchin moduli space

Lemma 4.1. Consider the constant "trivial" section

s: $\mathbb{C}P^1 \longrightarrow \mathcal{M}_{\mathrm{DH}}(X), \qquad \lambda \longmapsto (\lambda, \overline{\partial}, \lambda \partial)$

of f (see (3.2)). There exists an analytic open neighborhood $\mathcal{U} \subset \mathcal{M}_{DH}(X)$ containing $s(\mathbb{C}P^1)$ and an analytic open neighborhood \mathcal{V} of the zero section of

$$\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g} \longrightarrow \mathbb{C}P^1$$

such that \mathcal{U} and \mathcal{V} are biholomorphic.

Proof. Identify $\mathbb{C}P^1$ with lines in \mathbb{C}^2 by sending any $\lambda \in \mathbb{C} \subset \mathbb{C}P^1$ to the line generated by $(\lambda, 1) \in \mathbb{C}^2$ while the point $\infty = \mathbb{C}P^1 \setminus \mathbb{C}$ is sent to the line in \mathbb{C}^2 generated by (1, 0). The fiber of the line bundle $\mathcal{O}_{\mathbb{C}P^1}(1)$ over any point $z \in \mathbb{C}P^1$ is the dual line $(\ell^z)^*$, where $\ell^z \subset \mathbb{C}^2$ is the line corresponding to z. Hence $\mathcal{O}_{\mathbb{C}P^1}(1)$ has a canonical trivialization over \mathbb{C} (respectively, $\mathbb{C}P^1 \setminus \{0\}$) given by $\lambda \longmapsto \{c \cdot (\lambda, 1) \longmapsto c\}$ (respectively, $\lambda \longmapsto \{c \cdot (1, 1/\lambda) \longmapsto c\}$).

Let $\omega_1, \ldots, \omega_g$ be a basis of $H^0(X, K_X)$, where g = genus(X), and let $\overline{\omega}_1, \ldots, \overline{\omega}_g$ be the corresponding conjugate basis of $\overline{H^0(X, K_X)}$. Now let

$$\Phi: \ \mathbb{C} \times \mathbb{C}^{2g} \longrightarrow \mathcal{M}_{\mathrm{DH}}(X),$$
$$(\lambda, \chi_1, \dots, \chi_g, \alpha_1, \dots, \alpha_g) \longmapsto \left(\lambda, \overline{\partial} - \sum_{i=1}^g \chi_i \overline{\omega}_i, \lambda \partial + \sum_{i=1}^g \alpha_i \omega_i\right)$$

be the map. This map Φ extends to a holomorphic map

$$\mathbb{C} \times \mathbb{C}^{2g} \subset \mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g} \xrightarrow{\widetilde{\Phi}} \mathcal{M}_{\mathrm{DH}}(X);$$

recall that the trivial line bundle $\mathbb{C} \times \mathbb{C} \longrightarrow \mathbb{C}$ is identified with the restriction of $\mathcal{O}_{\mathbb{C}P^1}(1)$ to $\mathbb{C} \subset \mathbb{C}P^1$. This holomorphic map $\widetilde{\Phi}$ is a biholomorphism from an analytic neighborhood of the zero section of $\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g} \longrightarrow \mathbb{C}P^1$ to a neighborhood of $s(\mathbb{C}P^1)$.

The algebraic dimension of a compact connected complex manifold Y is the transcendence degree of the field of global meromorphic functions on Y over the field \mathbb{C} . The algebraic dimension is bounded above by the complex dimension. If the algebraic dimension of Y coincides with the complex dimension of Y, then Y is called Moishezon.

The definition of algebraic dimension does not make sense in general if Y is not compact. For example the transcendence degree, over the field \mathbb{C} , of the field of global meromorphic functions on the open unit disk is infinite. However, a theorem of Verbitsky says that the notion of algebraic dimension continues to remain valid, and it is bounded above by the complex dimension, if Y contains an ample rational curve [13, p. 329, Theorem 1.4]. In particular, the notion of algebraic dimension extends to the twistor spaces.

Proposition 4.2. The algebraic dimension of $\mathcal{M}_{DH}(X)$ coincides with dim $\mathcal{M}_{DH}(X)$, in other words, $\mathcal{M}_{DH}(X)$ is Moishezon.

Proof. Consider the compactification $P(\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g} \oplus \mathcal{O}_{\mathbb{C}P^1})$ of $\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g}$. Since it is a complex projective manifold, it is Moishezon. Now from [13, p. 337, Theorem 3.4] we know that any analytic neighborhood of the zero section of $\mathcal{O}_{\mathbb{C}P^1}(1)^{\oplus 2g}$ is Moishezon, because the zero section is an ample rational curve. Therefore, from Lemma 4.1 and [13, p. 337, Theorem 3.4] it follows that $\mathcal{M}_{DH}(X)$ is Moishezon.
